Subject

1. The above-mentioned students starts from in the school level as an external student at the Adventistische Privatschule Bogenhofen.
2. The subject of this agreement is the accompaniment of the student according to the principles of the Austrian curriculum for the "Mittelschule".
 - 2.1. The student is registered for the following subjects:

- 2.2. The school offers external students to take part in lessons via electronic media in the major subjects of Mathematics, German and English. The main disciplinary responsibility for punctuality, cooperation, and homework remains with the parents. The aim is to ensure that home school children receive systematic instruction from pedagogues and are taught the whole subject according to the curriculum.
- 2.3. For the provision and maintenance of the technical requirements on the part of the student, the parents are responsible.
- 2.4. Participation in the "Heimschule plus" program does not replace the "Externistenprüfung". The assessment of learning success will be done as feedback but does not have the character of academic achievement according to SchUG.
3. The student is obliged to integrate him-/herself into the community and order of the school and to contribute to the achievement of the learning and educational goal to the best of his/her ability. Directors, teachers, and other (volunteer) staff contribute to this.
4. The "Schulverein der Siebenten-Tags-Adventisten" is the school's operator – according to § 4.1 lit. c Privatschulgesetz – of the Adventistische Privatschule Bogenhofen.
5. Should any provision of this agreement prove to be ineffective or become ineffective due to a change in law, the remaining provisions shall remain in force.
6. Differing agreements must be made in writing.
7. Place of performance and place of jurisdiction is Braunau am Inn for both parties.

II

Duration

1. The agreement lasts until the end of the school year, unless none of the points described in part II. 3. have to be borne.
2. The contractual relationship may be terminated in writing by either party at the end of the school term, taking into account a 3-month notice period without giving specific reasons.
3. The school has the right to terminate the agreement without observing a notice period in the following cases and to initiate an exclusion procedure in accordance with § 49 SchUG:
 - 3.1. The student opposes the school partnership agreement or does not conform to the principles of the school or exerts a harmful influence on other students.
 - 3.2. The fixed payments are not made on time.

III

General

1. By signing the agreement, legal guardians consent to the computer-assisted processing of personal data. All changes to the master data of the student and the guardians shall be notified to the management in writing within one week.
2. The student or guardian agrees to the processing and disclosure of their data to fulfil this agreement and to fulfil obligations arising from laws, regulations, or administrative requirements. The school undertakes to comply with the GDPR with regard to the personal data of the student and the guardians. The current declaration of compliance with the information obligations in accordance with GDPR (Data Protection Declaration) is available on the school's website in the section DATENSCHUTZ.



IV Fees

1. The registration fee for "Heimschule plus" is 20 Euro.
 - 1.1. Upon re-registering for "Heimschule plus" for the coming school year up to the end of the first semester, the registration fee is not applicable.
2. Participation in the "Heimschule plus" program is subject to the following fees:
 - 2.1. participation in one subject (G, M or E) 80€/month
 - 2.2. participation in two subjects 150€/month
 - 2.3. participation in all three major subjects 210€/month
 - 2.4. Fees can be paid in ten equal instalments from September to June.
 - 2.5. Fees may be paid in full at the beginning of the school year.
 - 2.6. At the registration of a sibling child a monthly discount of 10 € per subject applies for the second child.
 - 2.7. SDA Church members receive a discount of
 - 2.7.1. participation in one subject 10€/month
 - 2.7.2. participation in two subjects 20€/month
 - 2.7.3. participation in all three major subjects 30€/month
3. For the optional participation in the "Externistenprüfung" the following reduced fees are applicable for participants in the "Heimschule plus" program, if the student has participated in the "Heimschule plus" program for at least 7 months:
 - 3.1. participation in one subject (G, M or E) 170€
 - 3.2. participation in two subjects 90€
 - 3.3. With participation in all three subjects no examination fee is required.
 - 3.4. The fee must be paid at the examination date.
4. Fees are due on the 5th of each month.
5. Due fees are to be transferred to the school's operator:
